Minutes

- **Welcome Address:**
- The Convenor welcomed all attendees and emphasized the university's zero-tolerance policy on ragging. The committee decided to rename itself the **Safe Campus Committee**, considering that no incidents of ragging have

been reported during its tenure so far, and to highlight the positive impact of the sensitization programmes.

- **Review of Previous Measures:**

- The committee submitted an application for a dedicated email ID: safecampus@philosophy.du.ac.in to the office of the HoD on 28th July 2025.
- The committee reviewed last year's actions. No incidents of ragging were reported.
- The online anti-ragging affidavits need to be submitted successfully by all students.

- **Plans for the Upcoming Session:**

- The committee has decided to strictly follow the guidelines provided by the Proctor, DU in the online meeting held on 28th July 2025.
- An orientation session will be organised for freshers during the first week of August.
- Anti-ragging posters and banners will be displayed prominently across the department and on the website.
- A grievance box will be placed in the department for anonymous complaints.

- **Awareness and Sensitisation:**

- A one-day Safe Campus (Anti-Ragging) day will be celebrated.

- Peer mentorship program to be strengthened to facilitate positive senior-junior interaction.

- **Committee Responsibilities:**

- Each member will be responsible for monitoring specific zones (Arts Faculty and Satyakam Building) of the department.
- Weekly checks will be conducted during August 2025.
- At least one member of the committee will be present at the department each day during August to monitor the situation.

- **Miscellaneous:**

- A WhatsApp helpline number will be circulated for emergency reporting.
- Suggestion to include alumni who experienced the transition before and after anti-ragging policies for a guest talk.
